

FECON LIMITED WARRANTY – Drum Mulchers Only

Please read this limited warranty carefully

Effective date 9/1/2024.

1. WARRANTY PERIOD

Fecon LLC warrants that drum mulchers sold by it will be free from defects in material and workmanship for the following periods:

- First Year**: Full coverage (parts and labor) for 1 year or 1,000 hours from the in-service date, whichever occurs first.
- Second Year**: **Parts-only** coverage for an additional year or up to 2,000 hours from the in-service date, whichever occurs first.

2. WARRANTY CONDITIONS

To maintain warranty coverage, the following conditions must be met:

1. Complete and submit the **Warranty Registration and Fecon Product Survey** within 60 days of purchase.
2. Follow and maintain proof of adherence to operational and maintenance guidelines as specified in Fecon technical publications.
3. All warrantable repairs must be performed by an authorized Fecon dealer or a Fecon-trained and approved technician.
4. This warranty applies only to new items manufactured by Fecon, unless explicitly stated otherwise in the sales contract.

*Note: Fecon reserves the right to deny or charge back any warranty costs if discrepancies arise regarding the purchase date or if warranty conditions are not met.

3. FECON'S OBLIGATIONS

Under this warranty, Fecon will:

- Repair and/or replace, at its discretion, approved parts.
- Cover reasonable and customary labor costs (first year only) necessary to correct the defect.

4. WARRANTY TRANSFER

This warranty is transferable to subsequent owners for the remainder of the warranty period, starting from the original in-service date.

5. WARRANTY EXCLUSIONS

This warranty does not cover:

1. Ground engaging wear items (e.g., tools, teeth, skid shoes)
2. Oil or other lubricants
3. Non-genuine Fecon parts or accessories
4. Damage resulting from the use of non-Fecon parts
5. Damage caused by improper maintenance
6. Regular maintenance services (e.g., tune-ups, adjustments, parts, lubricants)
7. Optional accessories and related damages
8. Damage from accidents, water intrusion, fire, misuse, abuse, or neglect
9. Damage from operation in incompatible conditions
10. Damage from unapproved modifications
11. Indirect or consequential losses (e.g., lost time expense, towing, rental vehicles)
12. Damage from improper storage
13. Vehicle delivery inspection

6. LIMITATIONS OF LIABILITY

1. This warranty is given in lieu of all other warranties, expressed or implied, including warranties of merchantability or fitness for a particular purpose.
2. Implied warranties are limited to the duration of this express warranty.
3. Incidental and consequential damages are excluded from coverage.
4. No person is authorized to make affirmations, representations, or warranties other than those contained in this warranty.
5. Fecon reserves the right to modify this warranty policy at any time, without altering warranty conditions for products sold under an active warranty.
